- Please name or rename your account showing your name and your organisation; people with unclear or sceptical identification may be refused admission.
- 3. Wait for the host to admit you into the **Zoom Meeting Room**.
- 4. During the Q&A session, when you want to raise a question, please submit it in writing to the host at the <u>Zoom Chat Room</u>; this is a backup measure so that in case of technical problem, your question may be read out by the moderator.
- 5. The host will then give you signal when it is almost your turn to ask your question.
